- Been successful in achieving key objectives (technology or product development; achievement of milestones; significant growth)
- Success in attracting outside investors or partnerships
- Growth in revenue or earnings
- Demonstrated the ability to balance science and business
- International presence and activity

- Statement of Nomination (max. 750 words) which outlines how the nominee meets the award criteria.
 - The BioAlberta Awards Committee will pay special attention to the following elements of each nomination statement:
 - The nominee's success in:
 - achieving key technology and business milestones,
 - attracting investors and/or generating growth in revenue or earnings
 - expanding its presence and activity (including international reach, breadth of products or services, or other types of expansion).
 - Lastly, the nominee's contributions to the life sciences industry in Alberta.
